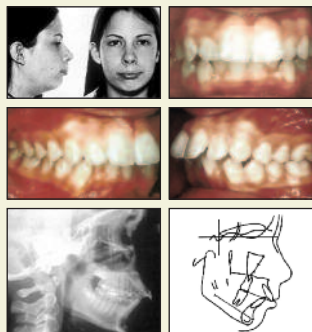

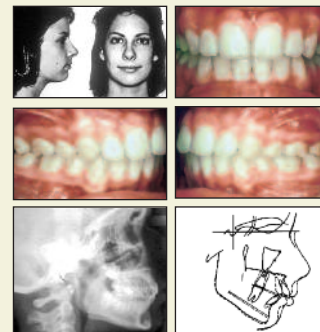

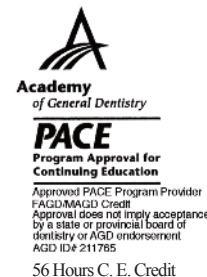

DR. RICHARD A. LITT received his D.D.S. degree in 1965 from the University of Detroit, and his Masters degree and certificate in Orthodontics from Northwestern University in 1969. Dr. Litt was Professor and Chairman of the Department of Orthodontics at the University of Detroit from 1969-80, and Clinical Professor and Director of Postdoctoral Orthodontics at the University of California, San Francisco from 1980-86.

Dr. Litt is a member of the American Association of Orthodontists, as well as various other groups. He has published many articles and is recognized as one of the most dynamic educators and clinicians in orthodontic education today. He was a member of the European Orthodontic Society, the Societe D'Orthopedie Dentofaciale in France and the Edward H. Angle Society of Orthodontists. He has been the orthodontic consultant to the Cleft Palate Center at Children's Hospital of Michigan and the Director of Orthodontics for the Pediatric Dental Residency Program. Dr. Litt started F.O.R.C.E. in 1985.
